The Washington County Commissioners met in regular session in the Public Meeting Room, Courthouse Square, Washington, Pa., with the following members being present: Commissioners Larry Maggi, Diana Irey Vaughan and Harlan G. SPECIAL ORDER OF BUSINESS

Mr. Maggi introduced Susan Morgan of the Redevelopment Authority to present a Local Share Account check to Mayor Brenda Davis of the City of Washington. Mayor Davis accepted the check and thanked the Redevelopment Authority and the Board of Commissioners for this check. She stated the check would be used for a 15,000 sq. ft. roof structure over the two parking lots South Main where the Farmers Market is located. She stated that very little money had to be contributed by the City of Washington for this project. The money that was contributed came from the impact fee funds.

Mr. Maggi introduced Veterans Affairs Director Barry Grimm, past director Harry Wilson and veterans advocate Roy Wise. Mr. Grimm stated on behalf of the commander of the 25th District of the American Legion Department of Pennsylvania, he was authorized to present the Commissioners with the American Legion medal. Mr. Maggi read a plaque congratulating the Pyrex Company in Charleroi on their 100th birthday. Plant manager, John Lackovic thanked the Board of Commissioners for this recognition. Mr. Lackovic stated that the Charleroi plant was built in the 1890's by MacBeth-Evans Glass Company; purchased by Corning in the 1930's; and then by World Kitchen in 1998. Pyrex was invented by Corning in 1912 and introduced to the market in 1915. The plant employees over 350 hardworking people.

Mr. Shoher read a proclamation that proclaims May as Older Americans Month. Accepting the proclamation is Washington County Director of Aging Services Mary Lynn Spilak and the Executive Director of Southwestern PA Area Agency on Aging. Ms. Spilak thanked the Commissioners and all older Americans that were in attendance for their contribution of knowledge and experience. Grenfell also thanked the Commissioners and thanked the older Americans for their contributions to this county and throughout the United States. Ms. Grenfell also thanked everyone that provides services to older Americans.

He stated that he has secured a copy of the report that he will forward onto Mrs. Cessna, Director of Planning. The Commissioners stated that some of the pages of their copy of the report are missing. He asked that there be no more flaring in the park. Mr. Donnan also stated that the Department of Environmental Protection did not issue a fine for the spill. The first spill resulted in a \$23,500 fine. He stated that Washington County received a D in the ozone report card.
