 - f. Map 7 Seems like numerous locations are missing. Century Inn, Crematory, Henry House, John White House, Trolley Museum, McGuffey, others? What is the criteria?
 - **g. Map 8 -** Better define parks and trails.
 - **h. Map 9 -** I dentify transportation only.
 - i. Create Map 10 to show utility service areas and broadband map.

- **2. Comprehensive Plan** Dr. Midla provided some written notes on corrections and recommendations.
- **3. Park Updates -** Ms. Cessna explained the various projects underway this

summer including paving, shelter construction in Mingo Park, trail construction in Cross Creek Park, shelter site prep and new docks in Cross Creek Park.
