

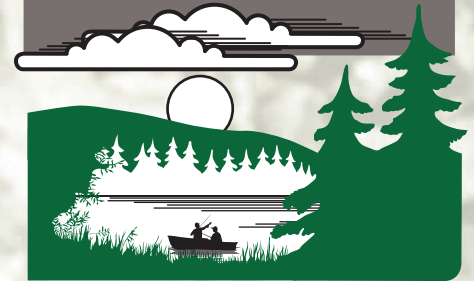

## HUNTING

### RULES AND REGULATIONS

★ *Applications will be accepted from Washington County residents and Washington County property owners beginning Monday November 10, 2025. Non-residents may apply for permits beginning Monday, November 17, 2025.*

- ★ A maximum of 75 permits will be issued for each day (excluding Sundays) **Friday January 2, 2026 - Saturday January 10, 2026.**
- ★ All hunters must comply with the Pennsylvania Game Commission Rules and Regulations for **Late Season Flintlock and Archery.**
- ★ Hunting is not permitted in designated Safety Zones. **Hunters must be aware that Mingo Park is open to many other recreational activities during the late season hunt.**
- ★ A non-fee permit issued by the Washington County Department of Parks and Recreation is required.
- ★ **Only deer hunting is permitted.**
- ★ **All deer harvested must be reported to the Park Office in Mingo Creek Park.**

## INSTRUCTIONS

- ★ Send a completed application(s), along with ONE copy of a valid **2025/2026 Pennsylvania Hunting License** and a self-addressed, stamped envelope to:

- ★ **No more than three (3) applications may be included in one envelope.**
- ★ Beginning **December 8, 2025**, applications will be accepted either in-person or through the mail.

- ★ ***An application must be completed for each day you wish to hunt.***
- ★ ***Incomplete applications, applications received prior to the correct due date, applications not including a self-addressed stamped envelope, and applications labeled "All Season" will be disregarded.***

(Flintlock ignition firearms only. The use of percussion or in-line ignition firearms, centerfire or rimfire rifles, or slug guns is **prohibited**.)
