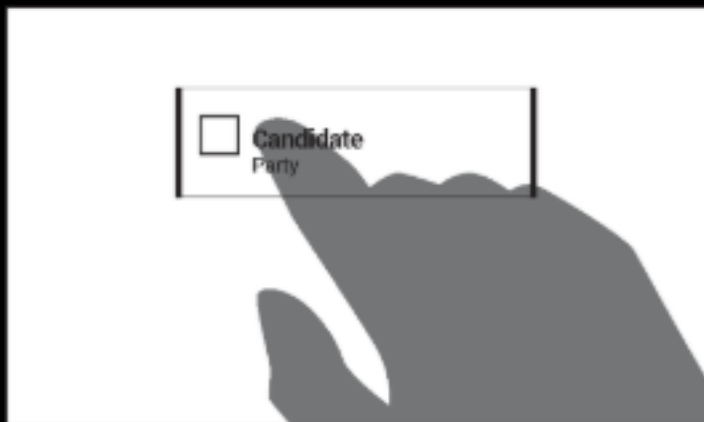




Help
