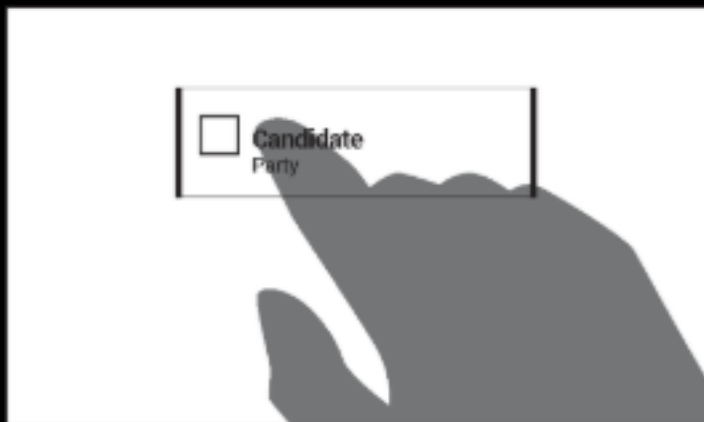




Help
