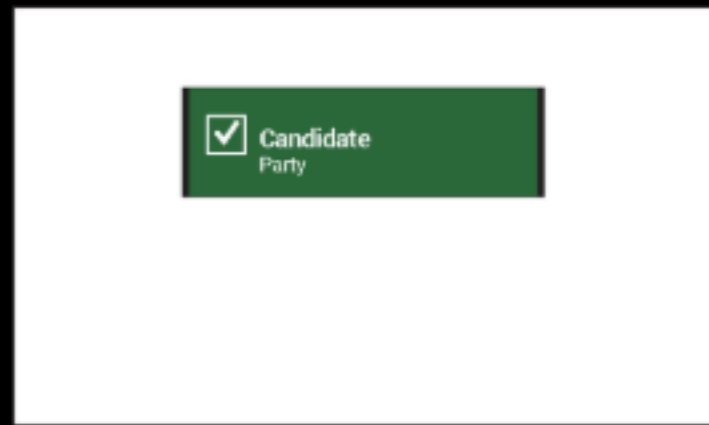
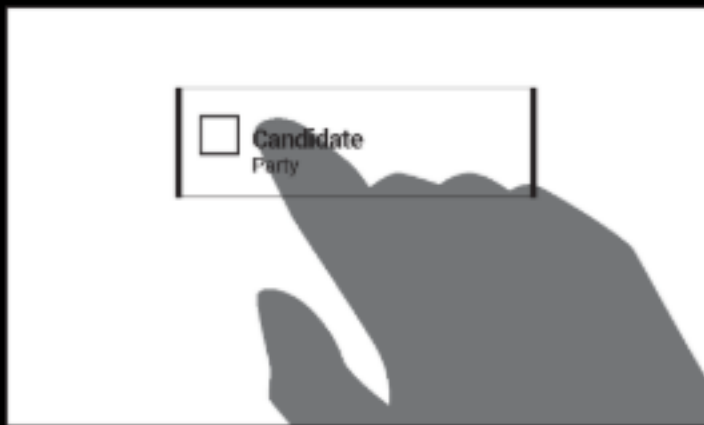




## Help
