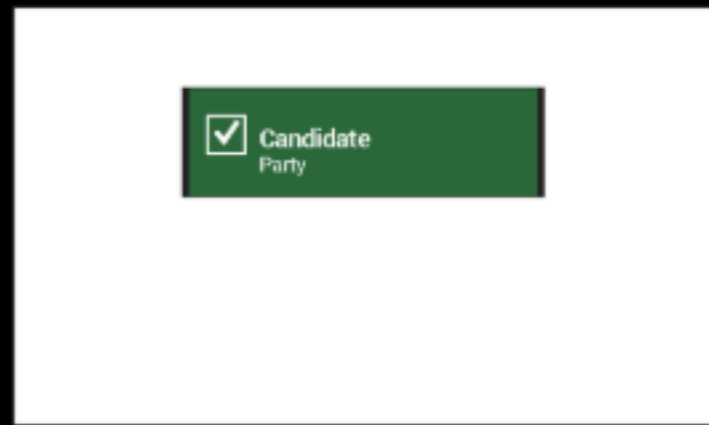
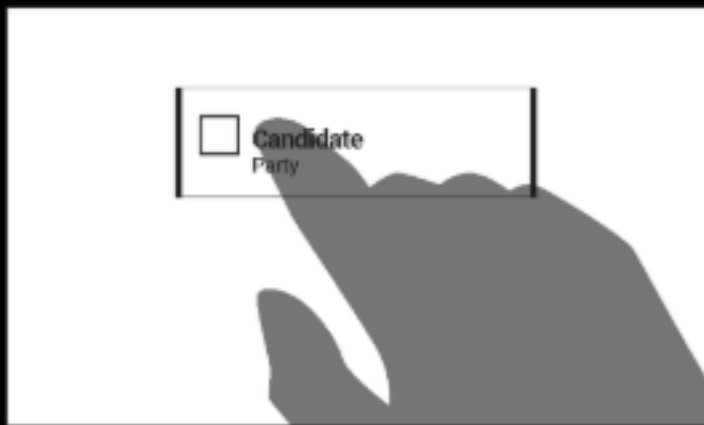




## Help
