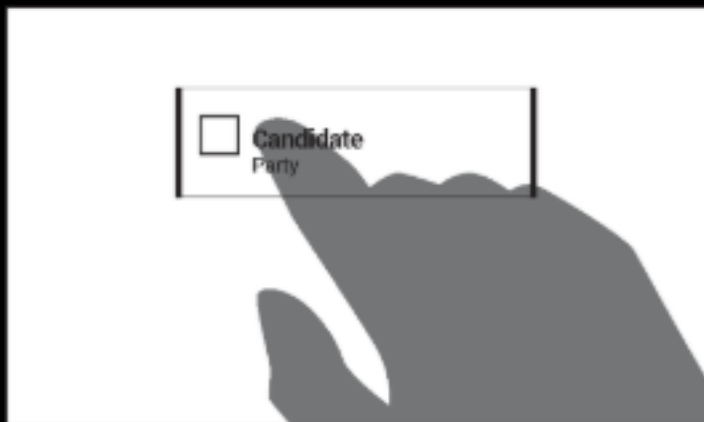




Help
