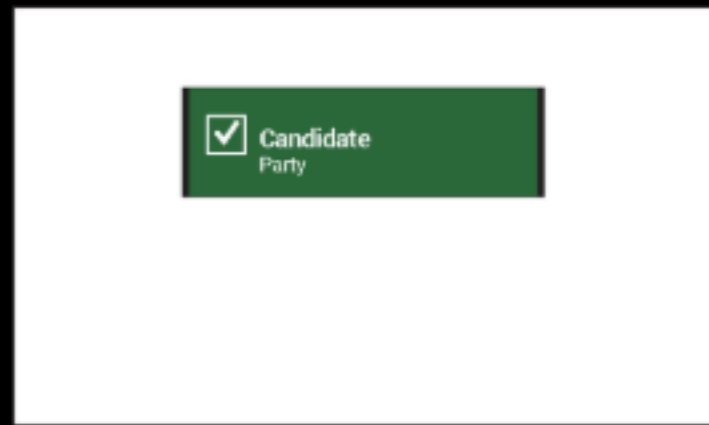
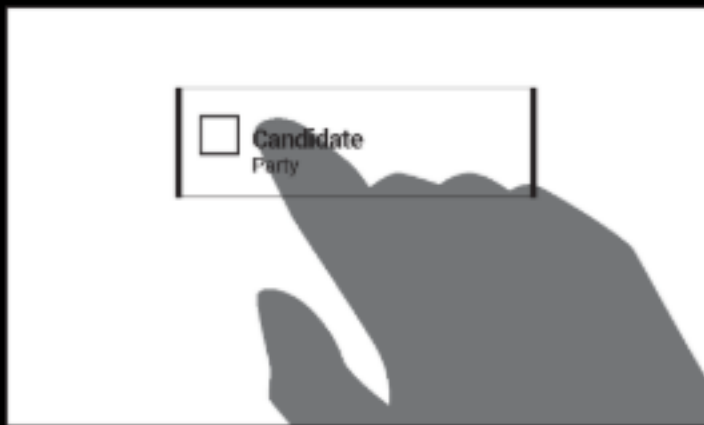




## Help
