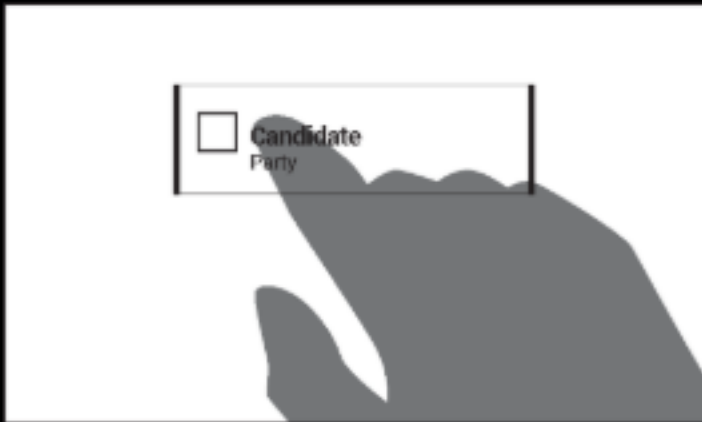




Help
