## APPLICATION FOR PROVISIONAL EMPLOYMENT UNDER THE CHILD PROTECTIVE SERVICES LAW ("CPSL") (FOR EMPLOYEES WHO HAVE DIRECT CONTACT WITH CHILDREN)

In accordance with requirements of the CPSL, as amended, I hereby apply for provisional employment up to forty-five (45) days with Washington County, hereinafter referred to as the "County", and in support thereof I do hereby swear and affirm that:

- 1. I have authorized the County to obtain a Pennsylvania (PA) State Police Criminal History Clearance (Act 34);
- 2. I have registered for a Pennsylvania (PA) Child Abuse History Clearance (Act 33) from the Pennsylvania Department of Human Services and will provide the County with the original clearance results:
- 3. I have applied for a Federal Bureau of Investigation (FBI) Criminal Background Clearance (Act 73) from the Federal Bureau of Investigation and will provide the County with the original clearance results;
