#### SPRING REPOSITORY SALE 2024 - Sale Conditions & Instructions

The Washington County Tax Claim Bureau tax sale for delinquent real estate taxes will be conducted as an auction. All Properties are sold pursuant to the Real Estate Tax Claim Law (RETSL), Act 542 of 1947, P.L. 1368, as amended. All title transfers are under and subject to the act.

\*\*All prospective buyers must **pre-register before the sale in the allotted time frame**, announced prior to each sale. All required forms shall be returned to the Tax Claim Bureau. No registrations will be taken after the cutoff date! Registration packets are available on our Web Site, <u>www.washington.pa.us</u> or in the Tax Claim Bureau office.

- 1. The properties are being offered for sale by the Washington County Tax Claim Bureau without any representation, warranty or guarantee whatsoever, either as to the existence, to correctness of ownership, the size, boundaries, location, structures, condition of structure(s) or lack of structure(s) upon the lands, liens, title or any other matter or thing whatsoever.
- BID PAYMENTS: Bid Money will be collected <u>IN FULL</u> at the Washington County Treasurer located at 95 W. Beau St, Ste. 130, Washington, PA 15301 by 3:00 P.M. the day of the sale. If payment is not received to complete the purchase, the bidder understands they will be permanently banned from attending or participating in any future sales in Washington County. Bid Money payments will be accepted in the form of cash, certified or cashier's check, money order, or Attorney's check. All checks should be made payable to the <u>Washington County Tax Claim Bureau</u>. No Personal Checks will be accepted for Bids Payments.

**TRANSFER TAXES** (calculated on the <u>sale price</u> of the property) and **RECORDING FEES** (\$84.25) are calculated separately from the bid price listed. However, you can pay for the entire bid amount, transfer taxes, and recording fees combined on one check. Local Transfer Taxes are 1% of the sale price OR 1.5% (Peters Township ONLY). State Transfer Taxes are 1% of the sale price. <u>BID AMOUNTS</u>, TAXES & RECORDING FEES ARE ALL PAID IN FULL as described above.

- 3. <u>SALE LISTS & OPENING BIDS</u>: The <u>REPO Parcel List</u> is a combined list of all unsold parcels from previous tax sales with the most recent being the 2023 Judicial Sale. Bids for non-trailer parcels listed on the REPO List begin at \$300.00 and \$150.00 for trailers/mobile homes.
- 4. The Tax Claim Bureau will issue a deed or bill of sale to the purchaser(s) and the deed shall be recorded before delivery to the purchaser(s). NOTE: the property will be deeded as listed on the Affidavit of Bidder and Affidavit of Non-Bidder Owner forms ONLY. No assignments of deed will be accepted!
- 5. The deeds will not be filed for at least 60 days following the sale. Entrance to the property is <u>PROHIBITED until a deed is received</u>. The present owner has the rights and responsibilities of the property until the deed is recorded in the purchaser's name and no rights of ownership are transferred until that time. The Tax Claim Bureau does not maintain any property sold at the sale in any way keys to the property are not provided to the successful bidder(s).
- 6. There will be NO REDEMPTION after the property is sold. All sales are final, NO REFUNDS will be given. If you rescind your successful bid on a property, you may be banned permanently from ever attending any future Washington County Tax Claim Bureau sale.
