

# REQUEST FOR VOTER LISTS FROM THE WASHINGTON COUNTY BOARD OF ELECTIONS

Pursuant to 25 Pa.C.S. § 1403 and § 1404 as well as the SURE Regulations at 4 Pa. Code § 183.13(c) (relating to Street Lists) and § 183.14(b) relating to (Public Information Lists) the following lists of public information are available to any qualified registered elector of Washington County.

- **Public Information List:** This is a listing of voters and contains name, residential address, mailing address, date of birth, status (active or inactive), party affiliation, polling place, voting districts, phone number if available, and date last voted. It is in Microsoft Excel format.
- **Public Information List with Voting History:** It contains the same information as the Public Information List as well as historical voting history. It is in Microsoft Excel format.
- **Street List:** This is a listing of voters and contains name, residential address, mailing address, party affiliation, and status (active or inactive). It is in Microsoft Excel format.
- **Walking List:** This is a listing of voters arranged by precinct then alphabetically by street name with house number in numerical order. Party affiliation and status (active or inactive) are included. It is in PDF format and is best viewed printed. It is intended to be used when you are physically visiting houses along a street and knocking on doors.
